**Terms and Conditions**

1. Monthly Payments are due at "Anthony Agudelo Landscaping inc" by the 10th day of each month.
2. Customer understands and agrees that any credit granted shall be paid promptly in accordance with the above terms, that the credit grantor may add two percent (2%) or \$5.00 per month, whichever is greater, to any past-due balance owed, and in the event of subsequent default further agree to pay reasonable collection charges and/or attorney fees and court costs.
3. Contract can be cancelled with 30-day written notice from either party. Upon Notice of Cancellation, monies owed for work performed prior to receipt of Cancellation are due immediately, in full.
4. If you are on the monthly payment option and you cancel you still may owe additional money. To determine this we will take the ("per cut charge") x (number of times done)-(monies paid to date).
5. Schedules are set to maximize performance; due to uncontrollable conditions (especially weather) we cannot specify an exact time of service.
6. Prices subject to change with 14 day written notice.
